

H&S AUTOSHOT MANUFACTURER STANDARD WARRANTY

Terms

Upon the following terms and conditions, H & S Autoshot (the Manufacturer) warrants the transformer to the purchaser of the stud gun models:

#9000 Deluxe Kit, #5500 Stinger Plus & #4550 Starter Kit: 3-YEARS

This warranty period (the Manufacturer's Warranty Period) applies from the date of purchase as registered by Purchaser.

Warranty applies only to registered product!

During the Manufacturer's Warranty Period, the Manufacturer or a designated Uni-Spotter service center will,

- (a) Confirm Warranty applies and, providing it does,
- (b) Repair this Uni-Spotter, or
- (c) Replace the Uni-Spotter.

In all cases, the customer/ dealer must **call Customer Service at 980-500-1015** to request a Return Goods Authorization (RGA) number and issue a Purchase Order or Credit Card charge authorization in the amount of \$125.00 USD. In the event the failure is WARRANTY, the unit will be repaired or replaced at no charge. In the event failure is determined to be NON-WARRANTY and the repair costs are less than or equal to \$125.00, the unit will be repaired, customer will be charged and unit will be returned to customer. In the event the cost to repair exceeds \$125.00, customer will be contacted to approve repair cost.

Conditions and Limitations

The Manufacturer does not obligate itself under this warranty to:

- (a) replace the complete Uni-Spotter, or
- (b) pay any transportation, freight, or handling charges incurred in connection with this warranty.

It is a condition of the Manufacturer's obligations under this warranty that this Uni-Spotter shall be:

- (a) operated in accordance with the operating instructions, or
- (b) used only for its designed purpose, and
- (c) put to normal use only.

The warranty shall become void if this Uni-Spotter is:

- (a) used improperly or altered or serviced by unauthorized personnel, or
- (b) damaged by transit, misuse, accident, neglect, flood, fire, line surge or act of God, or
- (c) if its factory applied serial number is removed or changed.

The Manufacturer shall not be liable or responsible for personal injuries or damage to real or personal property, caused directly or indirectly by this Uni-Spotter. This is the only warranty covering this Uni-Spotter given by the Manufacturer and no other warranty or condition, statutory or otherwise, is given or extended by the Manufacturer. To the extent permitted by law, the Manufacturer disclaims liability for consequential damages. Any gun repair done under this warranty is warranted by the Manufacturer, only to the expiration of the Manufacturer's Warranty Period. Any replacement part provided under this warranty is warranted by the Manufacturer, only to the expiration of the Manufacturer's warranty date.

Warranty Registration

It is extremely important that this **Uni-Spotter be registered immediately by the owner**.
