## Description

The 6865/6866 Apron Tapers provide a convenient method for laminating masking tape to the edge of masking paper to form an apron for paint masking. The 6865 and 6866 Apron Tapers feature top loading, and easy operation and adjustment.



#### **Set-Up Instructions**

#### Assembly

6865/6866: Packaged and shipped completely preassembled ready for use. Designed to be operated from a horizontal surface without permanent mounting.



Part Nos. 6865-6866 Apron Tapers (6865 shown)




Figure 1 – 6866 Mounting Hole Locations, Top View

## **Mounting Instructions**

The 6865/6866 Apron Tapers can be permanently mounted to a horizontal or vertical surface if desired.

6866: Four 5/16 inch diameter holes are provided in the tubular frame.

Refer to figure 1 for the mounting hole locations. For vertical mounting, pivot the knife bracket up 90°.

#### Loading and Operating Instructions

#### To Load the Paper Roll (Refer to Figure 2)

- Loosen, but do not remove, the wing nut on the left paper roll bracket (A). Position the bracket with the plastic hub facing in on the front cross bar 1/4 to 3/8 inch or 7 to 10 mm from the end. Tighten the wing nut to secure the bracket on the cross bar.
- 2. Loosen, but do not remove, the wing nut on the right paper roll bracket (AA). Position the bracket with the plastic hub facing in on the front cross bar to allow installation of the paper roll. Install the paper roll to dispense the paper toward the knife bracket (B). Place the paper roll core on the plastic hub of the secured bracket (A). Hold the paper roll horizontal with the spring brake (C) compressed under the roll, the spring brake being approximately centered under the paper roll. Slide the bracket (AA) in snug on the roll with the plastic hub in the paper roll core. Tighten the wing nut to secure the right bracket on the cross bar.

#### To Load the Tape Roll (Refer to Figure 3)

- 3. Loosen, but do not remove, the wing nut on the tape roll bracket (D). Position the bracket with the tape drum facing left on the rear cross bar and in line with the left edge of the paper roll. Tighten the wing nut to secure the bracket on the cross bar.
- 4. Place the tape roll on the tape drum to dispense the tape toward the paper roll, adhesive side down. Fully seat the tape roll against the tape drum flange. Pull 8 to 10 inches or 205 to 250 mm of tape from the roll and tack it to the edge of the paper roll even with the lead end of the paper.
- Break the seal on the paper roll and thread the paper apron between the guide spring (E) and guide roller (F). Pull the leading end of the paper apron out and forward under the knife bracket (B).

**To dispense paper apron** – Grip the lead end of the paper apron near the taped edge (do not touch adhesive) and, for best results, pull the desired length paper apron straight out smoothly as shown in figure 4.

NOTE: Pulling the apron out at an excessive side angle will cause puckering of the paper apron.

**To cut paper apron** – Move the full width of the paper apron against the serrated blade (BB). For best results, start the cut at the tape end of the apron. Maintain tension on the paper apron and continue to pull across the blade in the direction of the cut.

#### Adjustments

#### Tape Overlap (Refer to Figure 3)

For the best application results, maintain a 1/3 tape width overlap on the paper. To obtain proper tape overlap, loosen the wing nut on bracket (D) and slide it on cross bar. Tighten wing nut to secure the bracket on cross bar. The tape to paper overlap is self aligning as the paper apron is dispensed.

#### Spring Brake Position (Refer to Figure 3)

For best operating results, locate spring brake approximately at center of paper roll. To obtain proper position, loosen but do not remove, the lock nut on the spring brake (C) and slide it on the cross bar. Tighten the lock nut to secure the brake on the cross bar.






Figure 5 – 6865-6866 Replacement Parts

#### Parts Available For Inboard Paper Apron Edge Taping


The following standard apron taper parts are available to supplement the apron taper for dispensing more than one apron where taping either edge of the apron or aprons is desired. The use of these parts allows the use of 3/8 to one inch or 9 to 24 mm wide tape on both apron edges as shown. The 6865 combined paper roll width capacity is up to 15 inches [380 mm]. Maximum paper roll combinations include 12"/3" and 9"/6". Loading and operating is the same as the standard 6865-6866 apron tapers.


