3957() RUST PREVENTER is a non-hardening internal panel compound to replace OEM corrosion protection on inner body panels. It is semi-transparent black in color and is easily applied to inner panels with a 360° pattern using the 71110 PREMIUM UNDERCOAT GUN & WAND or the 71120 RUST PREVENTER AEROSOL WAND. It's fast drying formula is a simple way to restore corrosion protection on new parts and replacement panels.

Handling and Application

PREPARATION: Clean surface with 3837() SEM SOLVE or compliant cleaner.

APPLICATION: 39573 Aerosol

Shake can for 1 minute prior to use. Remove cap, attach straw or tip with wand.

NOTE: With the wand attached, the spray pattern is 360° so do not spray product without wand being inserted into inner panel access point.

Apply 1-2 coats. If using the wand, change the angle of the wand, and vary the depth of the wand inside the panel to ensure complete coverage. Clean wand by attaching the tip and wand to 77743 XXX GUN CLEANER or solvent compliant in your area.

39574 Quart

Shake bottle for 1 minute prior to use, remove cap. Attach 39574 to 71110 PREMIUM UNDERCOAT GUN & WAND.

NOTE: With the wand attached, the spray pattern is 360° so do not spray product without wand being inserted into inner panel access point.

Using 35-40 psi, apply 1-2 coats changing the angle of the gun, and varying the depth of the wand inside the panel to ensure complete coverage. Allow 2-3 minutes flash time between coats. Clean wand with 77743 XXX GUN CLEANER or solvent compliant in your area.

STORAGE:

3957() RUST PREVENTER should be stored in a cool dry place with adequate ventilation away from heat, sparks and flames. The shelf life for **3957()** and is 3 years when stored under normal conditions.
